## ST. CLEMENT'S CHURCH AUTHOR TO SPEAK ON SEPTEMBER 11, 2007

Join the Cass Gilbert Society on Tuesday, September 11, 2007, at 7:00 P.M. at St. Clement's Episcopal Church, 901 Portland Avenue (at Milton), Saint Paul. Please note the location. Hampton Smith, a member of the parish and author of The Spirit and the Bride: A History of St. Clement's Episcopal Church 1893-1996, will discuss the relationship between architect Cass Gilbert and the congregation. Gilbert's design was inspired by English Gothic prototypes. The book title comes from a verse from Revelation 22:17 that is inscribed over the chancel arch. Smith did much of his

research at the Minnesota Historical Society where he is a reference librarian.

The event will take place in both the sanctuary and the church hall so we will be able to see first hand the results of the collaboration of architect and congregation. Admission is free to Society members. There is a \$5.00 charge for nonmembers. Refreshments will be served, and copies of Smith's book (\$60 in hardcover and \$25 in paperback) will be available for purchase.



#### CASS GILBERT NEWS UPDATES

Cass Gilbert's **Lightner House** at 318 Summit was the site of a very successful fundraising event, held on July 19, 2007. For those who had attended the Society's hardhat tour last October while rehabilitation and restoration work was underway, it was fun to see the finished result. Thanks to **Dick and Nancy Nicholson** for opening the house, to restoration architect **Tom Blanck** for leading tours, and to architectural historian **Marjorie Pearson** for her presentation on the history and architecture of the house. Proceeds will be used to match the Minnesota Historical Society Grant-in-Aid for the redesign of the Society's website. The new website is scheduled to be ready in time for the National Trust conference.

The Waterbury City Hall has a new future. In early June the Board of Aldermen voted to appropriate \$35 million to renovate the Cass Gilbert building. The April 21 symposium organized by the Connecticut Community Foundation and the Mattatuck Museum Arts and History Center undoubtedly helped the City make a positive decision. Cass Gilbert Society members Barbara Christen and Helen P. Curry were symposium participants.

The West Virginia State Capitol, Cass Gilbert's last state capitol design, is celebrating its seventy-fifth anniversary. Both Helen Curry and Steven Flanders have visited Charleston, West Virginia, in conjunction with a documentary being made about the building by MotionMasters, Diane Dimoff, executive producer. Fred Armstrong, Director of Archives and History for the State of West Virginia, met with Helen on her July 20 visit.





Meanwhile the **Minnesota State Capitol** renovation has been sidelined due in part to differences between the State House of Representatives and the State Senate. The legislature appropriated \$250,000 to fund a Capitol Restoration Working Group to determine if the current renovation plan should be continued or if other strategies should be pursued for building upgrades and planning issues pertaining to the larger capitol complex.

# CASS GILBERT SOCIETY TRIP TO NEW YORK, NEW JERSEY, AND CONNECTICUT

Cass Gilbert Society members Helen Curry, Steven Flanders, and Jean Velleu have organized a tour of Cass Gilbert sites in New York City, New Jersey, and Connecticut, October 11-15, 2007 (Thursday to Monday). The itinerary offers a combination of organized events and free time for touring on your own. Participants will make their own arrangements for travel to and from New York City and for hotel accommodations in New York for Thursday and Friday nights. Participants will make their own arrangements for travel to and from New York and for hotel accommodations in New York for Thursday and Friday nights. A block of rooms is being held until September 13 at the Waterbury Marriott Courtyard (203-596-1000) for Saturday, October 13 (\$89), and the Norwalk Marriott Courtyard (203-249-9111) for Sunday, October 14 (\$79). Please make your own reservations directly with the hotels and refer to the Cass Gilbert Society to get the special rates. Those leaving for JFK airport on Monday, October 15, will be transported directly there. Others may go back to New York by train or with Helen Curry.

The registration fee is \$400 per person by September 10; \$500 per person if received after that date.

The fee includes the tour bus, entrance fees and gratuities, and four group meals. All participants must be current paid members of the Cass Gilbert Society. Membership is \$25 per year for individuals and \$35 per year for households.

#### Flight Information

Both Northwest Airlines and Sun Country offer early morning flights from MSP to New York JFK with evening returns. The current quoted round-trip airfare is \$218. If you do not have much luggage, the easiest route to Manhattan is to take the Airlink train from JFK (\$5) and transfer to the subway to get into Manhattan (\$2).

American Airlines is currently matching that fare with an early morning nonstop flight from MSP to New York LGA and an evening return.

Continental offers three morning flights from MSP to Newark (EWR) and evening returns with a current quoted fare of \$275 round trip. The EWR Airlink train connects to NJ Transit which goes to Penn Station in Manhattan two or three times an hour.
